	CCPED mails out approximately 800 surveys to gather public input. Surveys were also available at the Town Hall and during hand-out sessions at the town's transfer station.
December 2021	First Public Event (Public Launch). Held at the Fire Hall. Approximately 40 people attended. Introduction of the CP development process to the public.
January 2022 to June 2022	Regularly scheduled monthly meetings. Survey responses were tallied during this period. Nearly 200 individual survey responses were received together with dozens of separate comments.
July 2022	Second Public Event . Held at the Town Hall Pavilion. Approximately 30 people attended. Information stations were provided along with public survey results. Public feedback resulted in approximately 60 hand-written comments.
August 2022 to October 2022	Regularly scheduled monthly meetings. Refine data, refine vision/goals, draft write-ups.
November 2022	Third Public Event . Learn Mission/Vision/Goals and how they will appear throughout the CP. Presented information is a culmination of prior public input from CP survey and previous public event comments. The event also gathers additional public feedback.
January 2023	Comprehensive Plan (CP) steering committee adopts the draft CP (with comments) prepared by CCPED. The steering committee agrees the CP is ready for Planning Board review.
	CCPED provides full draft (with steering committee comments incorporated) to the Planning Board.
February 2023	Planning Board Special Meeting (2/2) to begin review of CP full draft ➤ 2/9- Regular PB Meeting (performed additional review)
